

CSS W/ELCA board focuses on education, ministry

As I write this, I find myself in the afterglow of our first in-person board meeting held March 18-19 in Overland Park, KS. Since being elected last September, we met monthly via Zoom and were thankful for the opportunity afforded us by technology. However, it was a blessing to finally be together! We had a most productive meeting and what a joy it was to be with this group of gifted women.

Our meeting began Friday evening as members shared their experiences participating in activities offered by the Churchwide Organization (CWO). Several members had taken part in the virtual leadership activity held in February, *“For Such a Time as This: Spirit Fed—Spirit Led.”* The three-day activity, provided opportunities for worship, Bible study, updates on the CWO, and numerous break-out sessions with hundreds of other synodical organization leaders.

In April and May, all members of the board and cluster coordinators will attend virtual training sessions that will address specific roles and responsibilities.

The CWO recently provided other quality learning opportunities, *“The Living History of Faith-Filled Women”*, *“Now Is the Time”*, and *“ELCA Declaration to People of African Descent”*. Our work continues to discover the status of congregational W/ELCA units across the synod. Many units have not returned to pre-COVID activities as meetings and other activities are still on hold. We rejoice with our nearly 70 active units and will support them in every way possible so they may return to at least a “new normal”.

It is challenging to connect with women in congregations where there are not active units. However, our constitution now defines and recognizes an active unit which has just one or two women. Much information and numerous learning opportunities are available to ELCA women, regardless of the size or involvement of the units.

Theme chosen for convention -- Beth Rockelman, vice-president

Rejoice in Hope, be patient in suffering, persevere in prayer. Romans 12:12

The 34th CSS W/ELCA Convention will be July 22-24 in Overland Park, KS. A walking nature trail is located behind the hotel and available to use. This year's theme is "Instill Hope and Share It" and the Bible verse is Romans 12:12: "*Rejoice in Hope, be patient in suffering, persevere in prayer*"

The convention and lodging will be at the Doubletree by Hilton Hotel, 10100 College Avenue (highway 69 exit). Lodging cost each night is \$149.00 + tax = \$175.97 (up to 4 in a room). This includes a "Grab-n-Go" breakfast Saturday and Sunday mornings. The costs for the meals will be: Friday night, taco buffet with dessert, \$18; Saturday lunch, salad bar with dessert, \$25; and Saturday dinner, chicken entrée, vegetables, salad, rolls, dessert. We have budgeted for about 100 women.

The 2022 convention registration information packets will be mailed April 15. Full Registration cost is \$90. Cluster coordinators will pay \$80 (a \$10 discount). The registration cost for Saturday only is \$50.

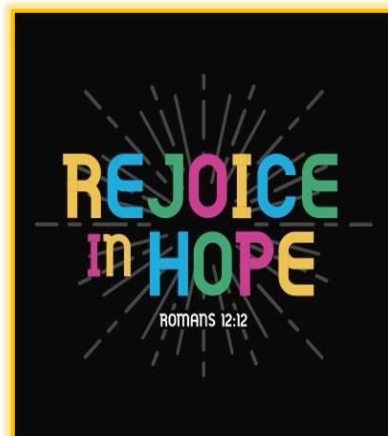

Just as spring comes about slowly, our clusters and congregational units also are starting to emerge from the past two years of the pandemic. Several clusters are planning in-person meetings for this spring and fall. Congregational units are returning to Bible study and meeting to tie quilts for Lutheran World Relief. But there are still challenges ahead. Some clusters are no longer active. Other clusters are in need of new leadership. Some congregational units have not returned to activities at pre-pandemic levels.

At the synod level, plans are well underway for an in-person convention, July 22-24 in Overland Park, KS. It is our hope that women from Missouri and Kansas will be able to reconnect at the convention and draw hope and joy from the speakers, activities, and fellowship with their sisters in Christ. We hope you will join us.

Bible study--Discipleship that fits

What comes to your mind when you hear the word discipleship? For most of us, we think of the command Jesus gave before ascension.

"Go therefore and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything that I have commanded you. And remember, I am with you always, to the end of the age." Matthew 28:19-20, NRSV

However, this command often is not easy to fulfill in our contexts. We get confused when asked to differentiate between evangelism and discipleship.

Dear sisters in Christ, I am very excited to share that we are going to study and learn together about, Discipleship that fits; Discipleship during the pandemic; and, how we survived in between times.

It is a pre-convention five-week ZOOM Bible study at 7 p.m. on Tuesdays. The dates are: May 10, 24, June 14, 28 and July 12.

The study will use the book, *Discipleship That Fits: The Five Kinds of Relationships God Uses to Help Us Grow*, by Bobby Harrington and Alex Absalom.

The book is available in paperback, Kindle, and used books at amazon.com.

"Discipleship That Fits..." shows the five key ways discipleship occurs. It addresses how Jesus turned men

into disciples and how disciples were shaped in the early church. Each context is necessary at different times and ways as a person grows toward maturity in Christ.

Public Relationships: The church gathering corporately for worship.

Social Relationships: Networks of smaller relationships where we engage in mission and live out our faith in community.

Personal Relationships: Small groups of 6-16 people where we challenge and encourage one another on a regular basis.

Transparent Relationships: Close relationships of three to four persons through which we share intimate details of our lives for accountability.

The Divine Relationship: Our relationship with Jesus Christ where we grow through the empowering presence of the Holy Spirit.

I invite you to join to learn together how to live and witness to be true disciples of Jesus Christ our Savior and Lord. Let us **REJOICE** in the **HOPE** believing in God's promise. ***"I am with you always, to the end of the age."***

Contributions are needed for scholarship program

The CSS W/ELCA sponsors an education scholarship for women who are members of an ELCA congregation. This scholarship became part of our ministry September 2014, when it was approved at the women's annual convention.

It was Rhonda Templing, former treasurer, and president of the CSS W/ELCA, and strong advocate of the scholarship, who encouraged the passage of the scholarship program.

The scholarship is available to high school graduates; women seeking a career change; or women wanting to further their education.

The one-year scholarship is non-renewable and does not exceed \$1,000 per recipient. Multiple scholarships may be given each year, depending on the monies available.

Applicants obtain a written recommendation and signature from their pastor, mentor, unit president or unit representative. They also submit an essay that describes their participation in church, school, and the community.

This scholarship program needs your assistance. Due to the two-year pandemic, many units and clusters did not meet. Nor were we able to hold our annual women's convention. Much of our scholarship funds come from those events.

The CSS W/ELCA board encourages units, clusters, and individuals to make contributions to support this valuable ministry.

This year's recipients are: **Emma Atcheson**, Resurrection Lutheran Church Haysville, KS; **Sapphire Davis**, Zion Lutheran Church Beloit, KS; and **Kelly Parr**, Trinity Lutheran Church, Hays, KS.
