Region 7 COVID-19 Fact Sheet

Topline Messages:

- FEMA and other federal agencies have been supporting The White House Coronavirus Task Force as part of a whole of government response to fight the COVID-19 pandemic and protect the public.
- On March 16, 2020, FEMA Region 7 activated its Regional Response Coordination Center (RRCC) in Kansas City, Missouri to provide a coordinated federal response to assist local, state and Tribal partners in the Midwest with COVID-19 efforts. FEMA Region 7 is comprised of the states of Iowa, Kansas, Missouri and Nebraska and is home to nine federally recognized tribal nations.
- Over 100 Federal staff have been deployed to assist with the Region 7 response to COVID-19. Other federal agencies that are assisting FEMA Region 7 include: The U.S. Department of Health and Human Services (HHS), its public health component known as Assistant Secretary for Preparedness & Response, the Department of Defense Coordinating Element, the U.S. Army Corps of Engineers, Cybersecurity and Infrastructure Security Agency, the U.S. Veterans Administration and the U.S. Department of Agriculture.
- On March 13, 2020, President Trump declared a nationwide emergency under the Robert T. Stafford Act to help reimburse certain emergency costs and/or provide direct federal assistance to local, state and territorial governments, as well as tribal nations. The states of Iowa, Kansas, Missouri and Nebraska were included in this sweeping designation.
- That assistance has been expanded to major disaster declarations granted by President Trump for the states of Iowa, Kansas, Missouri and Nebraska.
- Six of the nine federally recognized Tribes in Region 7 have received direct emergency declarations to help reimburse certain emergency costs and get direct federal assistance to support their tribal nations' COVID efforts. Those tribes are:
 - Ponca Tribe of Nebraska
 - Winnebago Tribe of Nebraska
 - Prairie Band Potawatomi Nation of Kansas
 - Kickapoo Tribe of Kansas
 - Iowa Tribe of Kansas and Nebraska
 - Omaha Tribe of Nebraska

FEMA Public Assistance (PA)

- The Public Assistance Program provides grants to state and local governments and certain non-profit entities to assist them with the response to and recovery from disasters.
- Emergency protective measures (Category B of Public Assistance) for COVID-19 under both types of declarations include such items as medical supplies, temporary medical facilities used to treat patients, and some labor costs for temporary medical personnel.
- FEMA has simplified the Public Assistance application and funding process to address the magnitude of this event.
- All local governments throughout the entire Region may now go to <https://grantee.fema.gov/> and begin the Public Assistance application process. State, local, and tribal applicants can now create their own accounts and submit RPAs (Request for Public Assistance) directly in Grants Portal without working through the Recipient.
- **On April 4, FEMA awarded \$44 million** to the State of Iowa to assist with its purchases in March and April of Personal Protective Equipment (PPE) such as isolation gowns, masks, face shields, safety glasses and gloves, thermometers, disinfecting wipes, sanitizer, respirators, and ventilators to assist hospitals, medical clinics, city and county governments, and certain private-non-profits across the state.
- FEMA continues to work with all of the States, Tribes and Local Governments in our Region to expedite funding for eligible COVID-19 related expenses.

U.S. Department of Health and Human Services (HHS)

- HHS has awarded more than **\$27 million** in coronavirus response grant funding to 29 Missouri community health centers (CHCs), **\$15 million** to Kansas to 19 CHCs, **\$11 million** to Iowa to 14 CHCs, and **\$6 million** to Nebraska to 7 CHCs. The funding will help CHCs meet staffing needs, and prevent, diagnose, and treat coronavirus patients.

U.S. Department of Housing and Urban Development (HUD)

- The Missouri Department of Economic Development (DED) will receive **\$13.6 million** in Community Development Block Grant (CDBG) funds from the U.S. Department of Housing & Urban Development (HUD) to support Missouri's COVID-19 response efforts
- HUD has made over **\$16 million** of COVID-19 Relief Funding Available to Communities in Nebraska, **\$33 million** to Communities in Iowa, **\$23 million** to Communities in Kansas, and over **\$57 million** to Communities in Missouri.
- HUD has made **\$2.7 million** OF COVID-19 relief funding available to assist Federally recognized Tribes in Region 7.

Alternate Care Sites (ACS)

- At the request of the state of Missouri and in an effort to be prepared, FEMA has mission assigned the U.S. Army Corps of Engineers (USACE) to convert hotel rooms in the St. Louis area into Alternate Care Sites (ACS).

- A mission assignment is a work order issued by FEMA to other Federal agencies, in this case the Corps of Engineers, to provide State, Tribal or local governments with resources to save lives, protect property, or preserve public health or safety under a disaster declaration.
- The build-out of an ACS does not guarantee that it will be utilized.
- Sites could potentially provide care to COVID and non-COVID patients. In general, states are speaking with local hospital systems to assess needs for additional facilities, medical equipment and supplies, and staffing. The U.S. Dept. of Health and Human Services and USACE are providing technical assistance, including advice about best practices.

Personal Protective Equipment (PPE)

- The Federal Government has provided approximately 1.2 million surgical masks, 1 million pairs of gloves, 500K N95 respirators, 200K surgical gowns, 245K face shields, and 7,500 coveralls to Region 7 States and Tribes.
- The entire federal family will continue to work both day and night to assist state, local and tribal partners in accessing equipment and supplies in our shared work to combat the effects of COVID-19.
